IFB ACHA – 1346 MOVING SERVICES – ACHA WIDE

The following changes and/or clarifications are hereby made by this Addendum No.1 to the above referenced Contract and becomes a part of the contract documents and supersedes any and all other documents hereinbefore issued.


ACKNOWLEDGE THIS ADDENDUM BELOW AND INCLUDE IT WITH YOUR PROPOSAL DOCUMENTS. THIS ADDENDUM MUST BE INCLUDED WITH YOUR SUBMITTAL TO BE CONSIDERED FOR AWARD.

MODIFICATIONS:

1. The Bid Due Date has been changed. Bids are due on Wednesday, February 10, 2010 at 2:00 P.M. EST.
2. SECTION A: SCOPE OF SERVICES, Item #2: The moving contractor shall be available to move tenants on a one (1) week notice. Moving operations shall be performed during preferred hours of 8:30am and 4:30pm, Monday through Friday. Additional days and times may be required. Exceptions include, but are not limited to large relocations associated with modernization projects, working families, complex moves, etc. The moving contractor shall be responsible to relocate the scheduled tenants of that time in the space of seven (7) working days of any given notice.
3. SECTION B: ADDITIONAL TERMS & CONDITIONS, Item #16: Insurance Coverage. The Contractor agrees to carry and maintain throughout the term of this agreement insurance coverage as follows:
 - a. Workers Compensation Insurance in accordance with the laws of the Commonwealth of Pennsylvania.
 - b. Comprehensive General Liability Insurance in the amount of \$1,000,000 per occurrence for bodily injury, personal injury, and property damage.
 - c. Automobile/Vehicle Liability Insurance in accordance with the laws of the Commonwealth of Pennsylvania.
 - d. The Contractor is required to carry a minimum of \$10,000 insurance per move to cover damage and/or loss of goods resulting from handling and/or transport. Goods include but are not limited to furnishings, fixtures, appliances, equipment, electronics, valuables, and other moveable property.

ADDITION:

1. SECTION B: ADDITIONAL TERMS & CONDITIONS, Item #32: Public Utility Commission License (P.U.C. Household goods movers operating within Pennsylvania are required to be licensed by the Public Utility Commission and must maintain adequate levels of insurance coverage and charge fees approved by the PUC. Provide evidence of P.U.C. licensure and P.U.C. number.
