Dear Applicant:

Thank you for applying for the Allegheny County Housing Authority's Low Income Public Housing Site Based Waiting List.

Please read and follow the instructions to our waiting list process before completing the application.

1. You must be 18 years of age to apply for Low-Income Public Housing.
2. Applicants applying for Low-Income Public Housing **may visit or mail the application(s) to the sites listed on the other page.** You may apply for one or more sites of your choice that you are eligible for.
3. **You will need to submit with your application(s) copies of your Birth Certificates and Social Security Cards for all family members that will be listed on your application. Photo ID is also required for anyone that is over the age of 18. Failure to submit the required information with your application(s) will result in your application being incomplete and unable to be processed.**

The Eligibility process is as follows:

1. Your application will be entered into the computer. Your application will be processed in date and time order of when your application was received at the site.
2. The Residential Property Manager will contact you by mail and or telephone with instructions to bring in information that is needed to process your application on a given date. Failure to do so will result in your application being removed (terminated) from the site waiting list.
3. Third party verifications will be completed based upon the information received.
4. A three-part background check will be completed. It will consist of a landlord check, utilities check, and a criminal background check that will be completed prior to moving into the site's unit.
5. During the eligibility process, a House Keeping Inspection will be conducted.
6. A letter will be sent to the applicant stating eligibility or denial.
7. You will be assigned to a unit in the Low Income Public Housing Community that you selected based on availability of your application date and bedroom size.

You must report in writing or stop by to the community of your choice any address changes, income, family composition. Failure to do so will result in your application being removed (terminated) from the site waiting list.

ALLEGHENY COUNTY HOUSING AUTHORITY

MEMORANDUM ON CRIMINAL ACTIVITY AND ONE STRIKE POLICY

Effective May 21, 2003, the following crimes which have been committed by individuals seeking to participate in the Low-Income Public Housing and Housing Choice Voucher Programs will now render them ineligible for a period of five (5) years from the effective *conviction date* rather than three (3) years unless otherwise stated. Ineligible individuals will continue to have the opportunity to establish, through the informal hearing process, why they should be eligible. A finding of any of the following offenses committed by an applicant and all adult household members in the five (5) years preceding the date of the application will result in a finding of ineligibility for the entire application.

- A. Offenses Involving Danger to another Person:
 - 1. Voluntary Manslaughter
 - 2. Aggravated Assault
 - 3. Involuntary Manslaughter
 - 4. Endangering the Welfare of a Child (case by case basis)
 - 5. Reckless endangerment of another person (case by case basis)

- B. Drug Offenses
 - 1. Possession of a Controlled Substance
 - 2. Possession with the Intent to Deliver a Controlled Substance
 - 3. The Manufacturing of any Controlled Substance or New Drug
 - 4. Possession of Marijuana

- C. Offenses Against Property
 - 1. Causing or Risking a Catastrophe
 - 2. Criminal Mischief (when amount exceeds \$5,000.00)

- D. Burglary and Other Criminal Intrusion
 - 1. Burglary
 - 2. Robbery

- E. Theft and Related Offenses – Felony – exceeds \$2,000.00
 - 1. Theft by Unlawful Taking or Disposition
 - 2. Theft by Deception
 - 3. Theft by Extortion
 - 4. Theft by Services
 - 5. Theft of Leased Property
 - 6. Theft by Failure to Make Required Disposition of Funds Received
 - 7. Welfare Fraud

For those individuals who have been convicted of the following crimes, you will be **PERMANENTLY INELIGIBLE**:

- 1. Murder
- 2. Rape and/or including any other Sex-related crime or (Megan's Law)
- 3. Kidnapping
- 4. Arson
- 5. Manufacture or production of metamphetamines on any federally assisted property.

**INCOME GUIDELINE EFFECTIVE FEBRUARY 2008
ELIGIBILITY FOR OCCUPANCY IN AFFORDABLE HOUSING THROUGH
THE ALLEGHENY COUNTY HOUSING AUTHORITY (ACHA)**

ACHA provides decent and affordable housing to eligible persons. In order to be eligible for low rent affordable housing, the applicant must qualify under ACHA's occupancy and admissions policies. Rent to be paid is based upon 30% of the adjusted gross income of the applicant. Applicants are offered an available unit when their name comes to the top of the waiting list.

In compliance with Section 504 of the Rehabilitation Act of 1973 as amended, the Allegheny County Housing Authority does not discriminate on the basis of handicap, physical or mental disabilities, in the admission of or access to affordable housing, or in the treatment of employees or applicants for employment. Any discrimination on this basis is illegal.
