

ORCHARD PARK CONSTRUCTION UNDERWAY IN DUQUESNE

With All PHFA, State, County and tax credit funding in place and the Ground-breaking Ceremony having been held in July, construction is officially underway on the new community of Orchard Park in Duquesne, PA.

As planned by the ACHA and Falbo-Pennrose, in association with WRT Architects, Fahringer, McCarty, & Grey, Inc., Mistick Construction, and the City of Duquesne, 44 Units housed in 22 new duplex buildings are being built on the former Burns Heights site. The new development also includes a free standing community building.

The removal of 45,000 tons of coal - an initial part of the process - has been completed and the excavation company has de-mobilized. Actual construction began in November of 2014. As of January 2014, all of the concrete pads for the buildings were completed. Most of the buildings are already framed and some are under roof. Bob Pacacha – ACHA Construction Manager on this project stated, "Finishes are coming out beautifully. Another job the ACHA can be proud of."

Meanwhile, the Youth Places Recreation Building, located on adjacent Walnut Avenue, is being prepped to provide (*continued on page 2*)

- Smoke-Free Initiative Adoption of smoke-free public housing policies and programs to assist residents with tobacco prevention and cessation.

GENERAL BRADDOCK TOWER - STANDING TALL AGAIN

General Braddock Tower has gone through three phases of construction and is now to begin a fourth. The first phase dealt with reclaiming the 10th, 11th and 12th floor units as well as introducing a new HVAC system, exterior improvements including a crowning new cornice and landscaping. The second deals with new windows and exterior lighting, while the third introduces a new chiller to the HVAC system providing the residents with unit controlled air-conditioning. The fourth phase will take the unit improvements through the remaining floors of the building.

Chuck Stohlberg, the ACHA Construction Manager stated that the initial work schedule might have presented a difficult time for the residents, but they were found to be quite helpful. Also, the new mechanical system and windows have made an immense improvement to the building's environment and the new overall look of the building is pleasing to the residents.

TRUMAN MODERNIZATION



The news at Harry S. Truman Apartments regarding construction progress is encouraging as the contractors (Moret Construction,Merante Plumbing, Merit Electrical Group and Controlled Climate Systems) work their way down through the building.

Initially the building received asbestos abatement of floors and ceilings, necessitating the relocation of all residents within the building. This however provided a much easier circumstance to perform the

work which includes the replacement of existing waste stacks which then ties into improving the apartments as well as the common areas with new kitchens and baths, flooring and paint. Additionally, HVAC and electrical upgrades as well as a new cornice, entrance and landscaping are included.

At this time, the seventh and sixth floors are being painted while drywall installation is being completed on the fifth, fourth and third floors. Of note are the new cornice and entrance canopy, which have been designed by McLean Architects to give the building an attractive entryway as well as a distinctive identity within the community.

SHELDON PARK IMPROVEMENTS

The ACHA is about to enter the third phase of exterior improvements to the 45 buildings at Sheldon Park. The first phase began in 2012. These improvements comprise brick repair, new insulation in crawlspaces, totally sealed LED lighting on porches, new roofing, windows and entrance canopies as well as new 100 square foot concrete patios.

Upstreet Architects worked with ACHA to develop unique roof overhang and bracketing details as well as colorful siding and picture framed windows to solve the initial problem of water infiltrating the dwelling units giving the buildings a cottage-like scale more appropriate to their park-like setting.

Additionally, the Lloyd Hayden Community Center has recently received upgrades of a new roof and HVAC rooftop unit.

ORCHARD PARK SECTION 3 JOB RECRUITMENT

The Allegheny County Housing Authority and Mistick Construction sponsored a job recruitment session on August 19, 2014 at the Boys and Girls Club in Duquesne. Notices were posted in the Duquesne Post Office, local supermarket, Boys and Girls Clubs and mass mailings to all former residents of the Burns Heights Community.

There were 48 applicants in attendance at the recruitment session. The first portion of the session consisted of ACHA and Mistick staff going over site drawings and the construction process taking place at the Orchard Park Development. For the next portion of the recruitment session, Section 3 applicants completed applications. ACHA's Kim Evans, Section 3 /MWDBE Coordinator and Mistick's Roxanne Thomas, Section 3 Coordinator conducted one on one interviews with Section 3 applicants to determine skills and also discuss training opportunities. A total of 64 Section 3 Resident job applications were received from Duquesne and surrounding areas.

ACHA's Section 3 Coordinator and Mistick's Section 3 Coordinator had various meetings conference calls with contractors and subcontractors to schedule interviews and drug testing for section 3 Applicants. We scheduled 41 interviews over the four month period. To date we have 17 Section 3 workers hired on this construction site. Our hope is that once completed the contractors/sub-contractors will retain the new hires to work on other contracts with them.

The applicants were tiered as follows; former Burns Heights Residents, Duquesne Residents and then the residents from the surrounding areas.

ACHA's goals are to increase Section 3 participation on all of our job sites promoting self- sufficiency, advancement and training opportunities to the communities and Section 3 contract compliance.
