

GRAND OPENING OF DORCHESTER OF MT. LEBANON SENIOR APARTMENTS

On May 14, 2019, Representatives from the Allegheny County Housing Authority, Oxford Development and Green Development officially opened Dorchester of Mt. Lebanon Senior Apartments located at 2903 Midland Street in Mt. Lebanon, Pennsylvania with an audience of well over 100 people in attendance.

The grand opening event was hosted by Dr. Howard B. Slaughter, Jr., President & Chief Executive Officer Habitat for Humanity of Greater Pittsburgh/ Board of Directors, Pennsylvania Economic Development Financing Authority, who introduced a host of speakers for the building's opening. The following persons spoke about the public/private partnerships that made this development a reality: Frank Aggazio, Executive Director of the Allegheny County Housing Authority; Grant Mason, Vice Chairman – Oxford Development; Ernie Sota, President of Green Development & Sota Construction Services; Jane Miller, US Department of Housing and Urban Development – Director of the Pittsburgh Field Office; Pennsylvania Senators Wayne D. Fontana and Pam Iovino; Rich Fitzgerald, Allegheny County Executive and Stephen McClean, Mt. Lebanon Commissioner. Funding for the project was made through the Pennsylvania Housing Finance Agency's (PHFA's) Low-Income Housing Tax Credit Program (credits being purchased by RBC Capital Markets & BNY Mellon), PHFA's Pennsylvania Housing Affordability and Rehabilitation Enhancement Fund (PHARE) and the Housing Trust Fund, Allegheny County Economic Development – CDBG program and the ACHA Capital Fund. Total project costs for the development were \$ 16,506,522.

This new development offers the residents of the 60 unit building features that are comparable to a market rate building. Designed to Passive House certification standards (the third largest Passive House building in the country), there are many energy efficient features in the building, including Energy Star appliances and windows, individual heating and cooling controlled systems. I am constantly impressed with the accomplishments and successes of our staff at the Allegheny County Housing Authority. There have been many new changes over the past year that all of the departments within the authority have handled with the utmost accuracy and attention to detail.

This May we opened our newest site, Dorchester of Mt. Lebanon. Our HMO and Development departments worked tirelessly alongside Oxford Development Co. and Green Development to complete the 60-unit tax credit senior apartment building. Allegheny County and the Department of Economic Development played a huge role completing this project, too. I am proud to mention that Dorchester of Mt. Lebanon is the largest Passive House development in the state and the third largest in the country.

Several of our public housing sites are receiving revitalizations in 2019. These include: Corbett, West View, West Mifflin and Wilmerding. I am looking forward to the completion of these projects. The work in these communities will enhance the quality of life for our residents.

Our Housing Choice Voucher Program, yet again, scored as a High Performer. It is important to mention that the staff did not miss a single point, receiving a perfect score. I am impressed that the HCVP Department continues to receive this recognition as they have over the past fourteen years. It truly shows their consistent excellent performance and their particular attention to detail which is very important when following complex regulations.

A special mention must be noted regarding the Housing Authority having no audit findings from our independent public auditors, Maher Duessel. I am proud to report that we have not had an audit finding in fourteen years.

Finally, I would like to take this opportunity to welcome our new board member, Sara Innamorato. Sara is the PA representative for the 21st State House District. She is very enthusiastic towards affordable housing. I look forward to working with Sara as the newest member of the ACHA Board of Directors.

Once again, the Allegheny County Housing Authority (ACHA) was designated a "High Performer" by the U.S. Department of Housing and Urban Development Section 8 Management Assessment Program (SEMAP). The HCVP administers over 5,800 vouchers including Veteran's Administration Supportive Housing (VASH) vouchers, Mod Rehab units and Mainstream vouchers.

The building is projected to use 29% of the energy that a typical building of similar size would use to operate. The building features fifty-two (52) one bedroom units and eight (8) two bedroom units in the South Hills community. There are multiple common area lounges on each floor which will allow the residents the opportunity to relax in the spacious building. Common area balconies are available for resident and guest use on each floor. A walking trial will be available which promotes an active lifestyle. Residents started to occupy the building in the middle of May 2019.

NEW DEVELOPMENTS

Robert J. Corbett Apartments

Capital funds were committed for kitchen and bathroom upgrades at Corbett Apartments. With supplementary ACED funding, additional scope items were included such as a new large patio area on the South end of the building and a new storage/trash collection enclosure. RW Sleighter, Engineers and Architects is the design team. The General, Mechanical and Plumbing Contractor is Liokareas Construction Company and the Electrical Contractor is Merit Electrical Group. Construction began in November 2019 and is scheduled for completion in August 2019.











Upcoming Projects

Wilmerding Apartments - Phase II Interior & Exterior Improvements

Common areas receive new flooring, paint, & lighting, elevator upgrades, interior & exterior signage, security camera system & fire protection upgrades. 28 efficiency apartments will be converted into 14 one-bedroom apartments. All apartment renovations include new kitchen and bathroom cabinets, counters, sinks, range hoods, tub surrounds, plumbing fixtures, lighting, new air conditioners, & fire sprinkler system; Other living spaces will receive new flooring and paint; Exterior work includes new facades at all entrances, a new key fob entry system, concrete walks & ramps, and a newly paved parking area.



The twin boilers supplying heat for this building are in need of replacement. Rey Engineering designed a replacement system in June/July 2019. Bids were collected in August 2019 and the low bidder was Beardsley Mechanical. Work is scheduled for completion before the heating season.



Design services for Blawnox have been secured with McLean Architects. Jefferson Manor design procurement will be complete in the 4th quarter of 2019. Work for both Roof Replacements will be scheduled to begin in the Spring of 2020. Work at Jefferson Manor also includes Make-Up Air Unit Replacement.

THE FIRST TEE CLINICS, PROGRAMS, & GOLF OUTING

It's an exciting time at The First Tee Golf Course at Pleasant Ridge, located in ACHA's Pleasant Ridge housing community in Stowe Township. The Frist Tee of Pittsburgh hosts classes there every day of the week, except Fridays. Currently, over 100 kids per week are participating in classes there.

The classes are open to the public and range from their TARGET level classes that are intended to spark curiosity in 5 & 6 year olds, to their PLAYer & PAR levels that teach Core Values, Golf Rules, Golf Etiquette, Golf Fundamentals, and Life Skills to kids ranging in age from 7 to 18. Participants come from all over Allegheny County and pay fees of \$60 per session. Residents of Pleasant Ridge qualify for special financial aid and can participate for free.

In addition to our Open Clinics, The First Tee of Pittsburgh also hosts groups from Sto-Rox High School, Allegheny Youth Development, the Bradley Center School located in Robinson, and Montour Elementary School's PTA Golf Club.

Thanks to the Annual Golf Classic, the facility is running great. Without the funds that come from the Golf Classic, The First Tee could never maintain the grounds or operate the building. The 2019 Golf Classic was held at Sewickley Heights Golf Club on Monday, August 5th and features a "play your own ball" outing with Shamble Rules being available as a handicap to the higher handicap players, 12 and above. We've found that better players enjoy playing their own ball when they have the opportunity to play at a great club like Sewickley Heights. We also understand that a course like Sewickley Heights can be quite difficult and tough on the high handicappers. That's why we let them move their ball to any tee shot in their group, then play-in from there, saving them from their errant tee shots. The competition for the day was the best 2 of 4 scores in your group per hole.

Although programs are going great at The First Tee Golf Course at Pleasant Ridge, the artificial greens are now 11 years old. They have passed their life expectancy and replacement is something that will be needed soon. If you or your company is in a position to help us upgrade our facility, please let us know. Participation in the Golf Classic is very helpful to the overall upkeep of the facility, but we really need a partner that is willing to go that extra mile to upgrade our facility to a place that will make a real impact on the kids that use it.


